| <p>You should engage positively in all practice experience learning opportunities, take responsibility for your own learning and professional development and know who to access support from when needed. You will be taught and supervised in accordance with your individual learning needs, proficiency and confidence. At mid-point of placement you will have opportunity to share and reflect on your placement experience and learning with your peers and an academic Link Lecturer in a safe and supported environment. Reflection will inform your on-going professional development and learning VLE portfolio.</p> <p>Continuous assessment using the digital ePad is an integral aspect of learning and teaching in practice and you are expected to show evidence of consistent achievement during Practice 1.</p> <p>You will work with and receive written and verbal feedback from a range of practice colleagues including practice supervisors and practice assessors. You will also be expected to seek written testimonies from service users.</p> <p>You are required to reflect on your developing knowledge and practice.</p> <p>Assessment is structured and recorded within your ePAD (electronic practice assessment record). You will meet with your practice assessor/supervisor at the start, mid-point and final week of Practice 1 to discuss your individual learning needs and progress. An action plan will be agreed and must be recorded in the ePAD at these points.</p> <p>Your practice assessor/supervisor and academic assessor will support and guide you towards successfully achieving the criteria set out in the Future Nurse: Standards of Proficiency for Registered Nurses and Standards for Education and Training (NMC 2018). Assessment of practice will be commensurate with Level 4 grading rubric within the e- PAD.</p> <p>If you are unable to achieve any standards of proficiency through lack of opportunity then this must be clearly documented in your Electronic Practice Assessment Document - ePAD.</p> |
