# **Outline Syllabus**

This module will introduce students to sources of evidence that may inform their practice as an occupational therapist. Students will consider how they can draw on research, practice guidelines, policy, legislation, strategy, expert practitioners, and service users and carers to inform their professional reasoning. This module will support foundation skills of searching for and appraising evidence.

## Learning, Teaching and Assessment Strategy

This module will engage students as an active learner. We are committed an inclusive universal design for learning. This module will use a flipped classroom approach to learning. Canvas will be used as a virtual learning environment for module information, handbooks, resources, teaching materials, films, and web-based materials. Students are expected to prepare for classes which focus on relating and applying knowledge to learning activities. Small group work will enable students to work through complex problems, with an emphasis on depth of content and learning. There will be interactive opportunities, such as debates and peer teaching. Service users and carers will contribute to teaching content and/or delivery.

Formative assessment, that informs the summative assessment, is embedded into the module teaching, and provides opportunity for self evaluation and peer and tutor feedback. There is one summative assessment. The module assessment must be passed at 40%
