Module Aims

Social psychology is concerned with the description and explanation of human behaviour in situations where people are interacting with others. In this module you will gain a comprehensive and critical understanding of the concepts and methods used in explanations of human behaviour when these are applied to individuals and groups in a social context.

The nature of groups will be considered including micro groups (for example friendship or work networks) and macro groups (for example culture). Substantive content will range from traditional social psychological theories and methods to more critical reflection on the replication crisis in social psychological research. Ethical issues in social psychological research will be a key theme throughout the programme as will the application of knowledge to our everyday behaviours and how we consider behaviour change in a social world.

Outline Syllabus

History of social psychology and its methods and the emergence of modernsocial psychology. Overview of individualistic and collective explanations for behaviour, reference to personality and individual differences and micro and macro social groups. Social perception including person perception, attitudes, and attribution. Inter/intra group processes including prejudice and conflict. Small group processes including norms, decision making and performance. Social influence including conformity, minority and majority influence. Throughout the module, the syllabus will focus on the replication crisis in social psychology.

Learning, Teaching and Assessment Strategy

Lectures will be used to deliver substantive content (LO1-3, 6). Lab work will be used to design a traditional social psychology experiment and analyse mock data allowing an experiential element of social psychological research to be incorporated into the module (LO2 & 4). Tutorials will be used to evaluate some of the main approaches in social psychology and for assessment preparation (LO1-5).

The Discussion section will assess an ability to demonstrate a critical understanding of some of the main social psychological approaches to social behaviour and behaviour change (LO1-5). Students would have completed the lab tasks and learnt on how to apply good research method and statistical analyses and now required to formulate a Discussion section that has both empirical evidence and critical analyses. The Discussion will also assess an in-depth appreciation and evaluation of at least one substantive theoretical and methodological perspective in social psychology. (LO1-6 based on the lab tasks in LO4-5).
