Module Aims

1. To theoretically explain how and why societies construct social norms.

2. To describe culture and meanings, their construction, maintenance and transformations.

3. To discuss the role of social structures and interactions in maintaining norms and defining deviance and criminality.

4. To consider these phenomena in light of contemporary changes brought about by the increasing influence of media and globalization in society.

5. To question concepts and theories through critically examining taken for granted explanations pertaining to crime and deviance.

6. To develop an academically nuanced perspective on norms, deviance, and culture in relation to policy and the criminal justice system.

Learning, Teaching and Assessment Strategy

Lectures will introduce key theoretical concepts. Group discussions will encourage reflection upon the 'normative' with reference to the lived experience of students. Consideration of data and cases studies of local, national and international phenomena will place norms and commonly held values into perspective and offer fresh insight into theoretical ideas and explanations of cultural production and the relationship between the individual and larger grouping or society. In this context, crime, deviance and its construction will be discursively conceptualized by students on the module.

Assessment is via a 2000-word essay. Students will be offered a range of framing questions which will allow the sociological and philosophical material taught on the course to be applied to contemporary phenomena. Students will choose one topic on which to write their essay.
