## Module Aims

This module places emphasis upon the application of social concepts and theories for the purposes of academic inquiry, research and practice. It aims to:

1. Demonstrate the uses of theory in the context of social inquiry, research and reflexive theorization about social issues and problems.

2. Describe dominant ways of thinking about the social world and explain the role of methodological traditions in the process of knowledge production.

3. Facilitate understanding through research and the practical application of academic skills.

4. Develop learners' reflexive understanding of social theory through complementary and/or contemporary conceptualizations of the social.

5. Support experiential knowing of the social world through the concept of the Sociological Imagination.

6. Provide an introduction to some of the ways in which social scientists/researchers work with participatory and community engagement practices to address public issues and problems.

## **Outline Syllabus**

Your ability to interpret the social world will develop in the context of interactive and iterative modes of teaching and activities. Learning will be led by the exploration of the following topics:

- Decolonising social science
- Social inquiry ? data sources and applications
- Interpreting power, ideology and social processes
- Alterity, social cohesion, diversity and inclusivity
- Public Sociology: Theories and practices
- Student activism and engagement
- Participatory Action Research (PAR)
- Community and policy development

Learning, Teaching and Assessment Strategy

Lectures will introduce you to key concepts and principles associated with the method and practice of decolonising social science, participatory research and public-facing social science practice (i.e. Public Sociology).

Workshops will enable you with the support of your tutor to steer your independent study towards social issues of personal/collective interest and importance/relevance. Interpretative and analytical skills will develop through the identification and examination of materials, data and sources. Group engagement will produce insight into local solutions to personal and collective issues and problems of public importance.

You will have the opportunity to work towards the completion of your assessments in workshops. The assessments for this module aim to a) promote the generation of knowledge in collaborative student-led circles of social inquiry; b) to expand theoretical and conceptual understandings c) to invent solutions to social problems through public engagement.
